I ENCLOSE THE FOLLOWING DOCUMENTS²:

- a) Copy of passport or, for EU students only, identity card.
- b) **Final PhD diploma** and **copy** of the official PhD degree awarded abroad corresponding to the third cycle under the Bologna Process qualifications framework and level 8 under the European Qualifications Framework EQF, awarded by an official higher education institution abroad, **translated by a certified translator into Italian or into English**. If the qualification is in English, a translation is not required.
- c) Certification issued by the competent Higher Education Institution abroad certifying the research and training activities carried out in order to obtain the PhD degree, as well as the duration of the PhD programme. Where the system abroad requires a Diploma Supplement to be issued also for PhD programmes, this document is also required.
- d) **Documents certifying** the **authenticity** of the qualification obtained abroad (one of the following):
 - "statement of verification" issued by an ENIC-NARIC centre (such as CIMEA)
 - legalisation by the relevant Italian embassy or consulate in the country
 - Apostille (where required under the Hague Convention)
- e) **Documents** certifying the **value** of the qualification obtained abroad (one of the following):
 - "statement of comparability" issued by an ENIC-NARIC centre (such as CIMEA)
 - Diploma Supplement drawn up in accordance with the European Commission model
 - Declaration of value issued in the country by the relevant Italian embassy or consulate
- f) Copy of the PhD thesis in pdf format and/or details of the internet address of the repository of the university or library where the approved thesis is kept and can be consulted, including details of the competent office to be contacted for authentication. The document must be submitted in the original language and translated into Italian or English by a certified translator. If the original document is in English, a translation is not required.
- g) Master's degree (final diploma and transcript) that granted access to the PhD programme obtained abroad, translated into Italian or English by a certified translator. If the qualification is in English, a translation is not required. The qualification must be accompanied by a declaration certifying its authenticity and a declaration of its value, as per points d) and e) above.
- h) Any **other document**: such as a CV, either in Italian or English.
