Oral examination includes the presentation of the research project and is intended to assess the suitability of the applicant for scientific research as well as the general knowledge of issues encompassed by the PhD Programme (see the list of research topics at the bottom of the present document). During the oral examination, the Admission Board will assess the applicant's proficiency in one of the chosen languages, according to each curriculum. The oral examination will be carried out in Italian and in one of the languages indicated in each curriculum.

Final Ranking List and Enrollment

After the publication of the results of the oral examination, the **final ranking list** will be available on the <u>University</u> <u>website</u>, selecting the relevant PhD Programme > "More information", section "Notices" at the bottom of the page.

Each position is reserved to one of the curricula of the PhD programme. Please note that for each Curriculum a specific sub-ranking list will be drawn up. Positions with a scholarship will be awarded on the basis of the Curriculum selected by applicants during the application stage and indicated on the cover page of the research project proposal. In case of vacancies, only after having scrolled the whole sub-ranking list, vacant positions shall be proposed to eligible applicants following the general ranking list.

Considering the expressions of interest for the **topic-specific position**, the Admission Board will establish if the applicant can be considered eligible for the allocation of the position linked to a specific research subject, considering their skills, experience, aptitude and research proposal. For the awarding or replacement of the topic-specific position, sub-ranking lists shall be drawn up. In case of vacancies, after having scrolled all the sub-ranking list for the topic-specific position, eligible applicants from the general ranking list related to Curriculum 3 shall be contacted.

Following the publication of the final ranking list, successful applicants shall **enroll** on <u>Studenti Online</u> by the deadline indicated on the <u>University website</u>, selecting the relevant PhD Programme > "More information". If a successful applicant withdraws from a position, the following applicant in the ranking list, who is also eligible for the specific position, will be contacted. During the replacement procedure, the new terms of enrollment shall be communicated via e-mail to the chosen applicant.

Research Topics

Curriculum 1: DESE - European Literatures

In accordance with the Excellence project "Diversity and Inclusion" pursued by the Department, the curriculum develops literary research in a supranational dimension in order to train specialists fluent in at least 3 languages who can manage different research typolologies, methodologies and cultural contexts in a strong international dimension thanks to agreements and conventions with foreign institutions. The theme for the 37th cycle of the PhD programme is "European Utopias". Fluent knowledge of Italian, French and English is mandatory along with other possible languages connected with the topic of the dissertation. The vehicular language in the PhD programme is French, the dissertation can be written either in French or in English. The discussion during the final exam will be in the languages the PhD student is required to know.

Languages: Italian, French, English. The main language of this curriculum is French. The thesis must be written in French or English. The final thesis defense will be carried out in the three languages of this curriculum.

Curriculum 2: EDGES – Women and Gender Studies

EDGES aims to investigate literature and cultural studies, gender methodologies and gender theories as places for the production, circulation and consolidation of cultures of equality, the valorization of diversity and social inclusion. In this perspective, EDGES shares the research aims of LILEC's mission on "Diversity and Inclusion". Interdisciplinarity is a privileged perspective of the curriculum. The scientific program is based on literary history and criticism, cultural studies, women's and gender studies, critical theories, and literature as a space for the production of critical thinking, the analysis of texts of different literary genres within their historical and cultural context, and the relationship between literature and visual cultures in a gender perspective. The research theme for the 37th call of the PhD programme concerns the study of Utopia in its various forms. EDGES will privilege the development of this theme from a gender perspective, following in particular the literary production and utopianism from Early Modern to the contemporary age. Utopia, dystopia and science fiction will also be analysed in contemporary literatures and visual cultures. EDGES includes a mandatory training internship on the subject of equal opportunities, access to education and valorization of diversity.

Languages: Italian, English, Spanish (for the latter the ability to read and understand a literary text).

Curriculum 3: World Literature and Postcolonial Studies

In accordance with the "Diversity and Inclusion (Dive-In)" Excellence project pursued by the Department, the curriculum World Literature and Post studies will offer theoretical approaches as well as cross-disciplinary and methodological insights in the specific areas of Postcolonial Studies, Transmedia studies, Border studies, Heritage studies, analysis of New Forms of textuality which are increasingly widespread in contemporary society. Particular attention will be devoted to the functioning of the world publishing market, translation policies, Migratory Phenomena and, more generally, the loosening of that link between language, culture and territory on which for at least two centuries the study of national literatures and the literary field partition were based. The topic of the projects to be submitted for the 37th cycle is "Utopia and dystopia" in its various forms.

Languages: During the oral examination the Admission Board will assess the proficiency of the applicant in two of the following languages (except the applicant's mother tongue), depending on the applicant's choice: Italian, English, French, Japanese, Spanish, Portuguese, Russian, German.

Please note: for the scholarship funded by the project ERC it is required:

- Languages: excellent command of English and reading knowledge of Ottoman Turkish and possibly of Russian. The oral examination will be held in English.
- Research Theme: The ERC project is a comparative study of cultural reforms, linguistic renewal and literary renaissance movements in three imperial traditions, Russia, Ottoman Turkey and Japan. The candidate is expected to work on the nineteenth century literature and culture in a comparative perspective within the scope of the research project, preferably with research interest in Digital Humanities. <u>Applicants interested in this scholarship must explicitly</u> indicate the research topic and curriculum 3 in their application and their Research proposal.

Curriculum 4: LINGMOD - Modern Languages Studies

This curriculum involves teaching and research on modern languages from the perspectives of pragmatics, communication, translation and translation theory, aiming to train specialists in at least two languages in different theories and methodologies. Languages must be chosen from the following: Arabic, Chinese, French, Japanese, English, Dutch, Spanish, Persian, Portuguese, Russian, German. The curriculum aims to provide a high level of scientific expertise, as needed to tackle linguistic and cultural diversity, as well as the major social challenges posed by multicultural and multilingual societies. The project must therefore be developed around the themes of diversity and inclusion that the Departmental excellence project is focused on. The study of diversity and inclusion, in the 37th cycle specifically, will be connected with the analysis of utopia-dystopia from a linguistic point of view. The curriculum prioritizes the study of language and languages in context and in action, especially as concerns their relation with sociocultural issues pertaining to inclusion in education and institutional communication. Scientific knowledge and methodological expertise are developed and enhanced through a variety of approaches, especially within the scope of the following disciplines: sociolinguistics, pragmatics, discourse analysis, conversation analysis, interactional linguistics, linguistic anthropology, applied linguistics, language acquisition, translation studies and digital humanities.

Languages: During the oral examination the Admission Board will assess the proficiency of the applicant in two of the following languages (except the applicant's mother tongue), depending on the applicant's choice: Italian, Arabic, Chinese, French, Japanese, English, Dutch, Spanish, Persian, Portuguese, Russian, German.
