## Final Ranking List and Enrollment

Considering the expressions of interest above for **topic-related positions**, the Admission Board shall express its view on the suitability of the interested applicants, taking into account their specific skills, experience and aptitude. Topic-specific positions will be awarded on the basis of the eligibility stated by the Admission Board. Should one or more of the abovementioned positions remain vacant, eligible applicants from the general ranking list may be contacted.

After the publication of the results of the oral examination, the **final ranking list** will be available on the <u>University</u> <u>website</u>, selecting the relevant PhD Programme > "More information", section "Notices" at the bottom of the page. Following the publication of the final ranking list, successful applicants shall **enroll** on <u>Studenti Online</u> by the deadline indicated on the <u>University website</u>, selecting the relevant PhD Programme > "More information". If a successful applicant withdraws from a position, the following applicant in the ranking list, who is also eligible for the specific position, will be contacted. During the replacement procedure, the new terms of enrollment shall be

communicated via e-mail to the chosen applicant.
