Oral examination aims to assess the suitability of the applicant for scientific research as well as the general knowledge of the research topics linked to the available PhD positions.

During the oral examination, the applicant's English language proficiency shall be assessed.

The oral examination is carried out in one of the languages of the PhD programme (Italian, English or French).
