The research activities encompass the systematic collection and rigorous analysis of data and information to carry out a series of case studies examining local policies and services – spanning the public, private, and third sectors – designed to support caregivers of older adults. The research explores centers of varying scales, ranging from metropolitan cities to small municipalities in inland regions, across multiple Italian territories.

Participation in the research activities of the **PREDLIFE consortium**, funded by the **Academy of Finland** and carried out by the University of Turku and the University of Jyväskylä (https://sites.utu.fi/predlife/en/) [PI of the consortium and leader of the sociological subproject: Dr. Satu Helske (University of Turku); PI of the statistical subproject: Dr. Jouni Hleske (University of Jyväskylä)]. Research activities encompass developing a robust theoretical framework to analyze how prevalent gender norms at both national and local levels shape fathers'uptake of parental leave. On the empirical side, a content analysis of Finnish party manifestos has been completed to construct two indices — measuring the level of "familialization" and "de-familialization" — which serve as proxies to assess the local prevalence of traditionalist or libertarian preferences regarding gender norms. Preliminary findings from this work were presented to a committee of the Finnish Parliament in October 2024 and have been incorporated into an article published in an international peer-

reviewed scientific journal (Class A, Scientific Disciplinary Area: GSPS-02/A). In June 2025, the project was renewed and expanded under the title *SHARELEAVE* − *Parental leave in context: social drivers of sharing care*, funded by the **Research Council of Finland** (€600,000, 2025–2028, PI: Satu Helske). I am involved as a member of the international research team with specific responsibilities in the comparative dimension of the project. SHARELEAVE adopts a multilevel longitudinal approach combining Finnish population register data with comparative data from Sweden, Germany, and the Netherlands. The project investigates how care arrangements are shaped by couple dynamics and social environments, with particular attention to social stratification and inequalities in leave uptake.

On the policy front, a comparative study of welfare policies in advanced economies was conducted using both qualitative and quantitative methodologies. This was followed by an in-depth exploration of specific policy domains, particularly social investment policies and family policies, as well as an examination of reforms enacted in Italy over recent decades. On the social stratification front, the research focused on analyzing survey data on social stratification across eight countries included in the PRIN project (Denmark, Sweden, France, Germany, Italy, Spain, the United Kingdom, and the United States). Special attention was given to the evolution of "class politics" in the post-Fordist era. The findings from these research activities have been published in four book chapters and numerous articles appearing in both national and international peer-reviewed scientific journals.
