### **Co-founder & CEO, Musawi, Pakistan**

**March 2018 - Present**

Musawi is an independent organization that advances evidence-based legal and policy reforms. Comprising a team of lawyers and public policy specialists, Musawi's specializes in rule of law and human rights, with a focus on increasing access to justice for marginalized groups and legally empowering them. Musawi is a member of the Asia Alliance Against Torture, the Asia Pacific Refugee Rights Network, Pakistan's National Alliance on Menstrual Hygiene Management and founding member of the Statelessness and Dignified Citizenship Coalition - Asia Pacific. Select project roles at Musawi stated below:

- **Team Lead, Protecting Women's Marriage Rights in Pakistan (December 2021 – August 2025) (ABA ROLI):** Responsible for oversight & technical support to all program activities and campaigns in Punjab, Sindh, Khyber Pakhtunkhwa (KP) & Islamabad Capital Territory (ICT), in collaboration with local partners, to improve knowledge and awareness of nikkahnama clauses and women's marriage rights across the country, strengthen laws and practices for registration and enforcement of the nikkahnama and other marriage processes for religious minorities, and improve women's practical access to the law through quality legal advice and representation on marriage related issues.
- **Co-Principle Investigator, Gender Responsive & Trauma-Informed Policing in Punjab (May - August 2023) (USIP):** Provided technical support to program activities to improve the capacity of the Punjab Police to respond effectively to women, girls and transgender persons within the criminal justice system by integrating best practices on gender responsive and trauma-informed policing. Key activities included developing trauma-informed training materials, conducting trainings of Victim Support Officers (transgender persons) and female police officers and developing a victim vulnerability assessment framework in collaboration with the Punjab Police.
- **Co-Principle Investigator, Citizen Centric Governance in Khyber Pakhtunkhwa (July 2021 - February 2023) (USIP):** Provided technical oversight to program activities and stakeholder coordination, along with Principle Investigator, to support building of a citizen-centric prosecution service in KP. Key activities included research to identify gaps in citizen-prosecution relationship and design and implementation of pilot citizen centric interventions in collaboration with the prosecution service.
- **Senior Researcher, Mapping of the Impact of COVID-19 on Stateless Communities in Pakistan (December 2021 - June 2022) (Institute of Statelessness and Inclusion):** Designed and conducted a research incorporating primary and secondary data collection and consolidated the findings in a first of its kind report documenting the specific impact of the pandemic on the stateless communities in Pakistan.

Supporting development of regional activities of A3T - a regional network working to prevent and pursue accountability for torture and serious human rights violations in Asia - to increase solidarity for human rights stakeholders in the region and foster sharing of localized advocacy strategies, experiences and best practices. Presently leading the network's youth engagement initiative, The Asia Classroom, a free one-month human rights course for 16-25 year olds from across Asia.
