More importantly, by clarifying the functioning and rationality of these justice systems, it plays an essential role in the inclusion of indigenous peoples and in reducing ethnic-racial prejudices and inequalities, especially with regard to access to justice and the proper functioning of the judiciary.The project counts with the expertise of socio-legal scholars, anthropologists and historians.
