- **MAJOR COLLABORATIONS**

- 2019-2022 In collaboration with Giorgio Lizzul (University of Warwick), I am organising a book project entitled ‘Rethinking the Early Modern Work Ethic’. The chapters of the book, written by twelve authors from eight different countries, were discussed on a workshop in Innsbruck in July 2021.
