PROFESSIONAL SERVICE (Brief Summary)

I have supervised 20 PhD students during my 9 years at Cambridge, and another 20 at US universities at which I had previously taught. At Cambridge, I have supervised about 40 MPhil students (about 4 per year). I have convened major research seminars at Maryland, Vanderbilt, and Cambridge, hosting about 150 presenters at Cambridge alone. I have served on numerous university committees while also chairing the Department of History at Maryland (2003-2006) and serving as Vice-Master of Sidney Sussex, my Cambridge college, across the most difficult pandemic year (2020-2021). I have served on the editorial boards of *Past & Present*, the *American Historical Review*, the *Journal of American History*, the *Journal of American Ethnic History*, and the *Journal of American Studies*. I have coedited a major book series for Princeton University Press, *Politics and Society in Modern America*, that has been operating since 2001 and has published more than 50 books during that span.
