Career

I am visiting professor of international political economy at the British University in Georgia, a faculty lecturer in law and ethics at Boston University in London, and have published works on US nineteenth and twentieth century history, and taught as a lecturer and seminar leader on US history for leading British and American universities since 1997. I have lectured and taught for the Oxford University Department of Continuing Education, the Oxford-Berkeley Programme, the University of Chicago Graham School, and various Ivy League courses as well as international undergraduate programmes based in London and Oxford. I have thirty years of extensive tuition experience specialising in undergraduate, A-level and IB economics, politics, undergraduate history, and law, and have established my own online tutorial business, Commonwealth Tuition. I have served as a Director of the Chicago Alumni course, overseeing seminars, lectures and academic delivery for the University of Oxford, Department of External Programmes (2004/5) now based at Kellogg College. I have also held jobs as Director of the Oxford Advanced Studies Programme managing Foundation-level Semester abroad programmes for Oxford Tutorial College (2005/6), and for Testprep Ltd's UKCAT courses (2006-9). I have maintained a relationship from 2004 with the ASE programme at Bath, and in that capacity have tutored undergraduates for Franklin and Marshall College in Virginia, Gettysburg College, and others. I am a Foundation School Governor (and vice-chair of Governors) for a small Primary School in Wandsworth, London, as well as member of the Governing Advisory Board of a well-known independent school. I was Principal at Chelsea Independent College for three years and vice-Principal for one year. I also served as co-Principal at Westminster Tutors in London, successfully guiding that college into the independent schools' association and inspectorate.
