INFORMATION ABOUT PROCESSING OF PERSONAL DATA pursuant to Article 13 of Regulation (EU) 2016/679

In the service/project **DISA Research Day 2024** are made some audio and video recordings and photographic services (hereinafter referred to as "Images") that are processed for teaching research and third-mission purposes.

Pursuant to art.13 of Regulation (EU) 2016/679 (GDPR), we hereby inform you that the Alma Mater Studiorum - University of Bologna will process images created exclusively for institutional purposes in compliance with applicable personal data processing legislation.

Purposes and methods of processing

Images will be processed, including via digital means, by subjects specifically appointed for institutional purposes, in the context of research, cultural and educational activities, for University publication and communication activities, as well as for purposes pursuant to art. 4 of D.R. 271/2009 (University Consolidation Act on Privacy and on the Use of Information Systems). Images may be published and shared on institutional websites as well as via social networking channels (including but not limited to, Facebook, Twitter and YouTube) pursuant to Law n. 150/2000, "Regulation of information and communication activities of public administrations".

The use of an image does not entitle the user to compensation of any kind.

The Alma Mater Studiorum - University of Bologna has the right to access or disclose user images without consent, pursuant to art. 97 of Italian law n. 633/1941. The use of images that may cause damage to the honour, reputation or dignity of the person portrayed, depicted or recorded is, under all circumstances, excluded pursuant to the aforementioned article and art. 10 of the Italian Civil Code.

Storage period of the personal data

Legal basis and nature of the provision of data

The legal basis for the processing is founded, pursuant to art. 6.1.e) of the Regulation (UE) 2016/679, in the institutional tasks entrusted to the Alma Mater Studiorum - University of Bologna, aimed at contributing to the social, cultural and economic development of society through research, teaching and the third mission.

The provision of data is obligatory for participation in the shoot. If you do not wish to be the subject of audio-video recording and/or dissemination of images, you will not be able to take part in the initiative in question.

Rights of the Data Subject

Without prejudice to the limitations placed on exercise of the rights of data subjects by arts. 2-*undecies* and 2-*duodecies* of the Italian Data Protection Code (Legislative Decree 196/2003), the data subject may exercise the rights granted pursuant and consequent to arts. 15-21 of the Regulation, including the right to request access to your personal data and its rectification or erasure, as well as to restrict the processing of your data, object to its processing and request its portability.

Requests to exercise the above rights may be presented to the data controller by contacting him at the addresses indicated above.

Lastly, should you believe that the processing of your personal data is in infringement of the provisions of Regulation (EU) 2016/679 or Legislative Decree 196/2003 and subsequent amendments and additions, you have the right to lodge a complaint with the Italian data protection authority's (known as the "Garante per la protezione dei dati personali"), pursuant to Article 77 of the Regulation (UE) 2016/679, or to refer to the appropriate courts (art. 79 of the Regulation).
