Global Contest: Liberal Democracy, Illiberal Democracy, Muslim Model of Society and Chinese State Capitalist Model in search of Local Clients

Theoretical considerations of disadvantages and pressing challenges facing liberal democracy as a model are considered in the context of empirical findings. The return of geopolitics is in the focus of this research seeking answers to the compatibility of particular political systems to specific socio-cultural communities. The question is whether a political contest between several global powers could become a 'continuation of politics by different means?'
