Biografia di Nik de Boer

Nik de Boer è professore associato di diritto costituzionale presso la Amsterdam Law School e membro del comitato editoriale della [European Constitutional Law Review](https://www.cambridge.org/core/journals/european-constitutional-law-review) (<https://www.cambridge.org/core/journals/european-constitutional-law-review>). La sua attuale ricerca esamina il declino democratico

e le preoccupazioni democratiche sull'architettura legale del sistema finanziario, con particolare attenzione alle banche centrali. Ciò si basa sulle sue ricerche precedenti, che riguardavano principalmente il ruolo delle corti costituzionali nell'UE. La sua monografia, *Judging European Democracy* (<https://global.oup.com/academic/product/judging-european-democracy-9780192845238?cc=nl&lang=en>), pubblicata dalla Oxford University Press, analizza sistematicamente la legittimità democratica delle revisioni del diritto europeo da parte delle corti costituzionali nazionali. L'obiettivo è fornire una nuova prospettiva sul ruolo di questi tribunali in relazione all'UE. Nik sostiene che, contrariamente all'opinione secondo cui la giurisprudenza delle corti costituzionali nazionali sull'UE favorisce il dialogo o la contestazione, la loro revisione potrebbe in realtà limitare il dibattito democratico sui fondamenti costituzionali dell'UE.

Nik de Boer guida il progetto multidisciplinare Salvaguardia dei fondamenti normativi della democrazia (<https://www.uva.nl/shared-content/uva/en/news/news/2023/11/democratic-decline.html>), ed è membro fondatore del consiglio di amministrazione della piattaforma UvA per la resilienza democratica (<https://democracy.uva.nl/>) (DEMRES).

Nik de Boer ha conseguito il dottorato di ricerca (cum laude) presso l'Università di Amsterdam nel 2018. La sua tesi di dottorato "Judging European Democracy" ha ricevuto il premio per la dissertazione dell'Associazione olandese di diritto costituzionale. Nik ha ricoperto incarichi in visita presso la Corte di giustizia europea, la Harvard Law School e il Center for Global Constitutionalism WZB, Berlin Social Science Center. In precedenza è stato ricercatore post-dottorato presso il Centro di Amsterdam per gli studi europei contemporanei (ACCESS EUROPE) e professore assistente presso il Dipartimento di diritto privato della Amsterdam Law School, dove non solo ha insegnato diritto finanziario ma ha anche coordinato il programma di Master in Diritto e Finanza e il programma di dottorato della facoltà. Nik è impegnato nello sviluppo di futuri studiosi e professionisti del diritto e attualmente insegna una varietà di corsi di diritto pubblico a livello di Master e Bachelor.
