#### **Brief Bio**

Dr Francesco Paolucci is Professor of Health Economics & Policy at University of Newcastle, Australia, and at University of Bologna, Italy. He is also the Associate Dean International of College of Human and Social Futures and the Coordinator of Value in Health Economics Policy group.

Before joining the University of Newcastle, he was Head of Health Policy at Sir Walter Murdoch of Public Policy and International Affairs, Murdoch University, Perth Australia. Prof. Paolucci was formerly the Chief Advisor Health Reforms to Minister of Health in Chile, and member of Italian Technical Committee for Allocation of National Health Budget (~200 billion euros). A scholar and advisor, who over the last decade has published extensively in the areas of public policy, economics and management with a strong focus on healthcare at a state, national and international level. His work includes five edited special issues in peer reviewed international journals (Q1) with editors and authors from over 25 countries. Prof. Paolucci has published over 110 academic peer-reviewed articles, book chapters and book reviews in a wide array of academic journals and presses, and in different languages. He published a one single-authored book ("Health care financing and insurance options for design". Publisher: Springer), and contributed with two chapters in book about the sustainability challenges and solutions healthcare systems are face globally (Risk Adjustment, Risk Sharing and Premium Regulation in Health Insurance Markets. Edited by Thomas McGuire – Harvard - and Richard C. van Kleef - Erasmus. Publisher: Elsevier). Francesco won the 40 Under 40 Awards by Business News tributing his entrepreneurship and innovation in internationalising and tailoring education to local and international industry needs. Highlights include over 20 years of engagement in health economics, policy and management in many countries (e.g. Austria, Australia, Chile, China, India, Italy, the Netherlands, Norway, Qatar, South Africa, Spain, UAE, UK, USA, Vietnam) through research, fieldwork and consulting experiences.

Prof. Paolucci has extensive international experience working as chief advisor to think-tanks, governments, industry. His academic output is internationally recognised. He is currently chief investigator on grants funded by the Australian Research Council, the National Health Medical Research Council, the European Commission (Horizon2020). Prof. Paolucci has been awarded industry grants from public and private agencies. He participates extensively in academic activities, conducting innovative research training activities, in the promotion of research studies, and teaching programs nationally and overseas.
