During my doctoral studies, I undertook independent research utilizing both experimental and realworld data to examine consumers' preferences for their primary health care provider. The context for all three papers was the U.S. health care system. Using patient narrative data, I demonstrated the broad scope in which patients describe their preferences and how these expectations may be predictive of how patients rate their provider. My research also showed that consumers' preferences for certain doctor attributes can shift following exposure to doctor-level performance data. Lastly, the concordance between consumers' preferences and their choice of doctor can be affected by patients' level of activation as well as their tendencies toward specific decision-making styles.
