I am a sociologist with a background in social policy and public services, with an expertise on street-level bureaucracy theory and gender (in)equalities.

Since April 2025, I have been a Fixed-Term Researcher (RTD-A) at Università Cattolica del Sacro Cuore in Milan. I am a recipient of the Young Researcher 2024 grant for Seal of Excellence MSCA-awarded researchers, studying the digitalization of Public Employment Services in Italy.

I obtained a PhD in sociology and social research in March 2020, undertaking ethnographic research on labour inspectors' discretionary power in dealing with labour exploitation cases. The research also provided a comparison between Italy and the Netherlands, using the innovative vignette technique.

The common threads of my career path concern not only the methodologies I use, which are mainly qualitative, but also the theoretical frameworks that I employ. I have always tried to observe the implementation of policies by focusing on how legislation becomes practice. The street-level bureaucracy (SLB) approach has been a main research focus and has led me to study the bureaucratic relationship between citizens and street-level bureaucrats.

In 2025, I obtained the *Italian National Scientific Qualification* (Abilitazione Scientifica Nazionale) for Associate Professorship (second-tier) in the field 14/D1 – Sociology of Economic, Labor, Environmental and Territorial Processes. My research mainly focuses on street-level bureaucracy, digitalization in the public sector, inequality, and the labor market.
