**Part. B. SUMMARY OF THE CURRÍCULUM**

Rolandino Guidotti was born in Modena on 12th August 1967 and graduated in Law at the University of Modena and Reggio Emilia with a final mark of 110/110.

Since 1993 he has worked in the Faculty of Law of the University of Modena and Reggio Emilia in the area of *Business Law*.

In March 1994 he passed the bar examination as a lawyer and was admitted to the Bar Association in November of the same year.

After working as a teaching assistant in *Insolvency Law* in the Faculty of Economics and Business (at the Rimini University site) from the following academic year (2002/2003) until (2007/2008) he taught *Business Law* in the same faculty (initially as a professor under a fixed term contract and subsequently as an external professor).

From October 2007 to August 2014 he was a Researcher in *Business Law* in the Faculty of Law of Bologna, where he taught *Business Law* and *Financial Market Law*.

Since September 2014 he has been Associate Professor in the School of Law in the University of Bologna where he teaches *Business Law*.

He continues to participate in several conferences, regarding the topics of *Company* and *Arbitration Law*; for a number of years he has taught in training courses, seminars and masters in various institutions.

He is the author of several publications in the areas of *Company*, *Insolvency* and *Arbitration Law*.

For some time he has been member of the board of directors of some Foundations.
